### What Are the Implication for Non-Compliance?

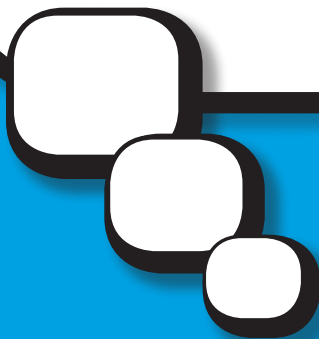
**2019 OSHA:** Average OSHA Fine = \$13K per visit  
 Not Rectifying the offence = \$130K  
 New CDC Infection Control Guidelines for Dental Office being **Strongly Enforced!**

**2019 HIPAA:** Fines = **Minimum** \$10,000- \$1.5M / Last 18 Months  
 HIPAA Audits begin in Dental / Medical Offices  
 Privacy & Security Practices to meet Omnibus Rule Standards Scrutinized
